The Two Burdens of a Christian

Embracing our Roles in the Kingdom of God

"It is for freedom that Christ has set us free." - Galatians 5:1. This declaration by Paul might seem self-evident—after all, what other purpose does freedom serve? Yet, this underscores the profound message Paul delivered to the Galatians. While the church in Galatia easily accepted that salvation comes through grace and not by works, they struggled with the concept that grace alone is sufficient for maintaining salvation.

The gentile believers were pressured to adopt Jewish customs like circumcision, dietary laws, and observance of holy days. Paul's interpretation of the law stood in stark contrast to traditional Jewish beliefs, which held that the promises of

Abraham were inherited by his direct descendants who adhered to the law, given the law was given 430 years after these promises.

Paul argued that the blessings were intended for Abraham's "seed," not "seeds" (Galatians 3:15-16), referring specifically to Christ, who fulfilled the law and thus inherited Abraham's blessings. Now, those who are in Christ, both direct and indirect descendants of Abraham, receive these same promises through faith in Jesus.

Being saved "not by works, but by grace" does not mean we have the liberty to live as we please. Rather, we are liberated from sin but bound to Christ. The oppressive yoke of curse and death is lifted, yet we are not without a yoke. We are invited to take on Christ's yoke, which is light and easy to bear (Matthew 11:28-30). Essentially,

the law of Moses is replaced by the law of Christ, which can be summarized into two core commandments: Love your Lord and love your neighbor (Matthew 22:37-39). In the concluding chapters of Galatians, Paul distills the law of Christ into two specific responsibilities (Galatians 6:1-10):

Burden #1: Phortion (Galatians 6:5)

This greek term refers to a backpack, symbolizing the load travelers carry. The first commandment of Christ instructs us to love the Lord with all our heart, soul, and mind. Although loving God might not feel burdensome, living in love requires effort. Paul emphasizes the fruit of the Spirit over the acts of the flesh, noting the singularity of the Spirit's fruit—either it is fully present, or it isn't.

“The Power of SWOT Analysis

Swot Analysis On Prominent Biblical Characters

WEAKNESSES OF ADAM AND EVE

In the previous Mission Updates, we discussed SWOT analysis and started with Adam and Eve's strengths in the last one. Let's look into some of their weaknesses.

WEAKNESSES OF ADAM AND EVE

1. DISOBEDIENCE TO GOD

Genesis 3:6-7

Genesis 3:6-7 (NIV) states, "When the woman saw that the fruit of the tree was good for food and pleasing to the eye, and also desirable for gaining wisdom, she took some and ate it. She also gave some to her husband, who was with her, and he ate it." Adam and Eve's decision to eat the forbidden fruit is a clear example of their disobedience. This act not only broke God's command but also led to dire consequences for themselves and humanity.

2. LACK OF SELF-RESTRAINT (Genesis 3:6)

"Genesis 3:6 indicates their failure to exercise self-control despite knowing the consequences. "She took some and ate it." Eve's immediate reaction to the fruit shows a lack of restraint. This inability to resist temptation reflects a broader human weakness, highlighting the struggle with self-control.

3. SHIFTING BLAME (Genesis 3:12-13)

Genesis 3:12-13 says, "The man said, 'The woman you put here with me—she gave me some fruit from the tree, and I ate it.' Then the Lord God said to the woman, 'What is this you have done?' The woman said, 'The serpent deceived me, and I ate.' Rather than taking responsibility for their actions, both Adam and Eve blame each other and the serpent. This evasion of accountability shows their inability to confront the consequences of their choices head-on.

4. LACK OF FAITH

Genesis 3:4-5

Genesis 3:4-5 shows the serpent questioning God's command, leading Eve to doubt God's intentions: "You will not certainly die... For God knows that when you eat from it your eyes will be opened, and you will be like God." Adam and Eve displayed a lack of faith in God's word and goodness. They allowed doubt to creep in, which ultimately led to their downfall.

5. VULNERABILITY TO TEMPTATION

Genesis 3:1

Genesis 3:1 states, "Now the serpent was more cunning than any of the wild animals the Lord God had made." The presence of the serpent illustrates their vulnerability to external temptation. Instead of standing firm in their beliefs, they succumbed to the manipulation of the serpent, illustrating a weakness in their spiritual endurance.

The Two Burdens of a Christian

Interestingly, while many things were created in Eden, fruit was not directly made by God; instead, He created plants and conditions conducive to fruit production. Similarly, Christians are encouraged to focus not on the fruits themselves but on being fruitful—hence the burden through personal devotion, meditation on scripture, worship, fellowship, and church participation. The byproduct of living by the Spirit is the fruit of the Spirit, beginning with love.

Burden #2: Baros (Galatians 6:2)

This greek term refers to the burden we share when a fellow Christian stumbles—a trespass rather than continual sinfulness. Paul specifies that this involves lifting the load from someone who has momentarily been overtaken by sin. Bearing one another's burdens means more than merely tolerating each other; it involves actively supporting one another, much like Christ did for us. Paul uses a medical analogy ("Katartizo") to describe this correction, likening it to a surgeon carefully removing a growth to heal a patient. Importantly, the focus is on cure, not on punishment. This burden falls on everyone who possesses the Spirit, not just church leaders (Galatians 6:1). As Christians, let us rejoice and be thankful that Christ has removed the oppressive yoke of sin and death, and traded us His yoke which is light. Let us also be diligent in meeting the expectations of the Kingdom of God and be faithful in carrying the two burdens the Lord has laid on us.

Key Takeaway

The phrase '**not by works but by grace**' does not imply that we are free from all burdens. Instead, it means we exchange the burdensome yoke of sin and death with the lighter, more manageable yoke that Jesus Christ offers us. This yoke comprises two specific burdens: **(1) Phortion** – the duty to live fruitfully by the Spirit, manifesting in actions such as prayer, studying scripture, and participating in community worship, and **(2) Baros** – the responsibility to support our fellow believers in times of spiritual struggle with sin. Unlike natural trees that inherently produce fruit, living by the Spirit results in fruitfulness as a natural byproduct, not as a direct objective.

TRANSITIONING FROM MONOCROPPING TO MULTI- CROPPING IN GARO HILLS

The Garo Hills of Meghalaya, with their rich biodiversity, are facing challenges due to monocropping—leading to soil depletion, pest infestations, economic risks, and biodiversity loss. A shift to multi-cropping is essential for sustainability, improved farmer incomes, and ecological balance.

✓ **Agroecological Practices** – Diversifying crops (millets, pulses, vegetables), integrating agroforestry (fruit trees with staple crops), and adopting natural pest control.

✓ **Traditional Knowledge** – Modifying shifting cultivation (Jhum), preserving indigenous seeds, and promoting medicinal plant farming.

✓ **Soil & Water Conservation** – Implementing contour farming, mulching, and rainwater harvesting.

✓ **Community Engagement** – Strengthening farmer cooperatives, training programs, and women's participation in agriculture.

✓ **Market & Policy Support** – Encouraging value-added agro-processing, organic certification, and government incentives.

As part of its mission to uplift rural communities, **P R Baby Foundation** is actively working with farmers to implement sustainable multi-cropping. The foundation conducts training on organic farming, promotes seed preservation, and facilitates access to government schemes. By mobilizing self-help groups, supporting farmer cooperatives, and introducing agro-processing units, we aim to enhance incomes and ensure long-term agricultural sustainability in the Garo Hills.
